

# **SINGLE-USER LICENSE AGREEMENT FOR RULE INDUCTION KIT FOR TEXT**

**IMPORTANT-READ CAREFULLY.** The Data-Miner Single-User RIKTEXT License Agreement ("SURTLA") is a legal agreement between you (an individual or a single entity) and AI Data-Miner LLC (henceforth, "Data-Miner"). for RIKTEXT, the Rule Induction Kit for Text, which includes computer software, datasets and "online" or electronic documentation. By downloading, installing, copying, or otherwise using RIKTEXT, you agree to be bound by the terms of this SURTLA. If you do not agree to the terms of this SURTLA, destroy all of your copies of RIKTEXT.

## **SOFTWARE PRODUCT LICENSE**

RIKTEXT is protected by copyright laws and international copyright treaties, as well as other international property laws and treaties. RIKTEXT is licensed, not sold.

**1. GRANT OF LICENSE.** If you have purchased a copy of "Fundamentals of Predictive Text Mining" this SURTLA grants you the following rights:

You may install and use one or more copies of RIKTEXT, the actual number of copies corresponding to the number of separate copies of the book that you have purchased. Each individual copy must reside on a single computer.

You may also store or install one copy of RIKTEXT on a storage device, such as a network server, used only to install RIKTEXT on your other computers over an internal network; however, you must acquire and dedicate a license for each separate computer on which RIKTEXT is installed or run from the storage device. A license may not be shared or used concurrently on different computers.
