

SINGLE-USER LICENSE AGREEMENT FOR TEXT-MINER SOFTWARE KIT

IMPORTANT-READ CAREFULLY. The Data-Miner Single-User TMSK License Agreement ("SUTLA") is a legal agreement between you (an individual or a single entity) and AI Data-Miner LLC (henceforth, "Data-Miner"). for TMSK, the Text-Miner Software Kit, which includes computer software, datasets and "online" or electronic documentation. By downloading, installing, copying, or otherwise using TMSK, you agree to be bound by the terms of this SUTLA. If you do not agree to the terms of this SUTLA, destroy all of your copies of TMSK.

SOFTWARE PRODUCT LICENSE

TMSK is protected by copyright laws and international copyright treaties, as well as other international property laws and treaties. TMSK is licensed, not sold.

1. GRANT OF LICENSE. If you have purchased a copy of the book "Fundamentals of Predictive Text Mining" this SUTLA grants you the following rights:

You may install and use one or more copies of TMSK, the actual number of copies corresponding to the number of separate copies of the book that you have purchased. Each individual copy must reside on a single computer.
